### CRITERIA FOR NOMINATIONS

Nominees must be a registered client of the Singapore Association for the Deaf (SADeaf).

\* Deaf refers to people with different degrees of hearing loss.

### NOMINATION PROCEDURES

1. Nominations must be made on the appropriate form, accompanied by an audiogram of the Nominee taken within the past 6 months, put in a sealed envelope and dispatched either by hand or by mail to:
