### ABOUT THE AWARD

The Teacher of the Year Award is conferred annually by the Singapore Association for the Deaf (SADeaf) to recognise the contributions of teachers of Deaf\* students

\* Deaf refers to people with different degrees of hearing loss.

### ELIGIBILITY

1. The nominees must be Singaporeans.
2. The nominees must be full time teachers; dedicated and willing to spare time and effort for the benefits of the deaf students in the classroom and beyond their call of duty in the last academic year\*

\* For Primary and Secondary Schools, this refers to the period as from January 2008 to December 2008.  
For Polytechnics and others the academic year varies, hence this is referred to the recent past academic term.

3. **Only one nominee will be conferred with the "Teacher of the Year Award" each year.**

### NOMINATION PROCEDURES

1. Nominations can be made by anyone (self-nomination is not eligible) and must be supported by their respective schools.
2. Nominations must be submitted and arrived SADeaf by 20 November 2009. Late submissions will not be entertained.
3. Nominations can be made on photocopied forms.
